Umzimkhulu Industrial Holdings (UIH) (Pty) Ltd owaziwa futhi nohweba ngegama iRossmi wenze isicelo segunya lezemvelo eliqala emuva ngaphansi kwenombolo KZN 30/5/1/2/2/299MR ukwandise nokwelula ingqalasizinda yemayini emhlabeni iWest Slopes No. 5828 ET, Oshabeni, ngaphansi kukamasipala wendawo iRay Nkonyeni Municipality. Lesicelo esokuqinisekisa ukuthi konke okwenzeka njengamanje kusemthethweni, hhayi ukwelulwa kwendawo ngokuzayo noma ukuguqula indlela okusetshenzwa ngayo.

Inhloso yalomqulu weminingwane ukunika ithuba kulabo abanentshisekelo nabathintekayo (Interested and Affected Parties/I&AP) imininingwane ngaphansi komthetho isigaba 24G weNational Environmental Management Act ufundwa kanye nesigaba 24F, nokunye okuyingxenye yesicelo. Abathintekayo nabanentshisekelo banethuba lokubhalisa ohlelwani lokubandakanya umphakathi benze iziphakamiso nokuphawula kulokucwaningo.

Umsuka:

Umzimkhulu Industrial Holdings (UIH) (Pty) Ltd owaziwa nohweba ngegama iRossmi unemayini yedwala le-limestone endaweni Oshabeni kanti unamalungelo okumba ezindaweni ezimbili eziqondene nezaziwa ngeNdongini ne Westlands.

iRossmi isendaweni esemaphandleni nokuyibanga elingamakhilomitha ayishumi uma ungena ngaphakathi kwendawo Umtentweni phakathi komfula uMzimkhulu nomgwaqo iSt. Faiths Road, kanti igxile kakhulu kwezolimo. Indawo Oshabeni inezidingo ezinqala ezimbalwa kanye namathuba ambalwa kwezomnotho nancike kakhulu ekulimeni umoba namantongomane.






Ibalazwe 1: Uma ubuka uphezulu ngokwebalazwe imisebenzi yabakwa-Rosmin

IRosmin yasungulwa ngo- 2014-2015 kulanlala ukuthola igunya lezemvelo kanye nelokumba.

IRosmin isenyakatho yosebe lomfula Umzimkhulu eMarble Delta kanti inamatshe ohlobo lwelime amanigi angaphansi komhlaba, nokwenza ukuthi inkampani ikwazi ukwenza imikhiqizo eseizingeni eliphezulu lwecalcit esetshenziswa kwezolimo kanye nedolomic esetshenziswa imboni yezokwakha. Inkampani yakwa Rossmin igaya lamatshe iwenze abe wusayizi odingwa abathengi ngokusebenzisa izindlela zakamuva zokumba nezokuhlunga ngaphansi komhlaba.

Icalcite nedolomite ambiwa enkwalini ahanjiswe lapho ezohlungwa khona. Imishini yokugaya neyokuhlunga ehlukene iyasetshenziswa ukuqinisekisa ukuthi amatshe ohlobo lwelime aseizingeni elidingwa abathengi.




Figure 2: Ingxene ye pulazi iWest Slopes No 5828 ET eyayingabaliwe njengendawo evikelekile ngokwezemvelo.

- U-0.82Ha kwakutshalwe kuwo umoba.
- U-1.61Ha kwakuyidlelo lemfuyo
- U-1.05Ha awuthikamezekile uyihlathi kanye notshani.

Ngesikhathi kuqalwa imayini ngo 2014 Abaphathi bakwa Rossmin babezitshela ukuthi yonke imigudu ilandeliwe. Ukucwaninga kwezemvelo kokuqala kwensiwa ngo-April 2014. Isaziso sokuhubeka senziwa kuMnyango weZokumbiwa phansi kanye noMnyango weZokuthuthukiswa koMnotho ngo 18 July 2014.

Umsebezi wokuqala wawubandakanya ukuhlola amanzi angaphansi komhlaba ngokumba imigodi ukulandela imiyalelo yomnyango wezamanzi, ukuhlola kuSub 2 wepulazi iWestlands kwindawo i MR299 ngoSeptember 2014.
